AUDIT EXECUTIVE SUMMARY:

H H Dobbins was est in 1905 and employees 85 people for apple and cherry production. Scope of audit was apples and cherries. Packingshed is 96,000 sq ft with 7 CA rooms and 4 regular storage rooms. Site also has two cool storage and control atmosphere sites within 1 mile of packingshed with a total of 10 rooms between the two sites. Site is located in Lyndonville NY and majority of workers are from the area. There is 1 production line per crop. The Apple packing line is a wet line, with a dump tank wash step, and spray bar which are called control points (CP). Material used included free cholerine, PAA, and Phosphoric Acid. Ozone is also used at site. The remaining steps include: receiving, sorting, dump tank, washing, sizing, packaging, storage, and shipping. Cherry line is a dry pack line, and prior to packing all fruit is hydrocooled (fungicide). A fungicide is used in the hydrocooler. Site has been GFSI certified for several years. No CCP were determined for process. One shift at site, from 7 am to roughly 4 or 5 pm, Monday to Friday with some Saturdays. Second shift includes a 10 person, sanitation crew, work hours are 4 pm till 12:30 am daily.
